

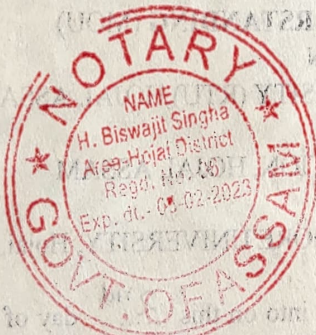

NOW THIS MEMORANDUM WITNESSETH and it is hereby agreed by and between the parties hereto as follows:-

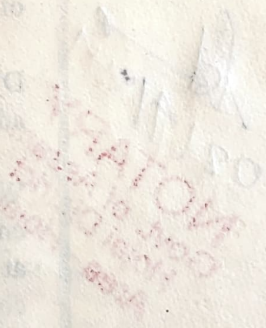

3) That this agreement shall never be construed as any tenancy agreement or lease agreement nor otherwise creating any right or interest in the property in favour of the First Party which is not at all intention of the parties but on the contrary merely an agreement simply to allow the First Party to use the stadium for arrangement of sports and game by the university.

4) That the agreement shall remain in force and / or continue for the period as long as both the parties agreed upon it.

5) That the cost and expenditures required for arrangement of sports and game shall be borne by the First Party including its bills of electricity if consumed by it for this purpose.
