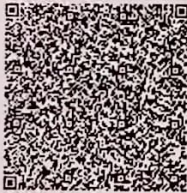



This Memorandum of Understanding (MOU) is entered into on this 7th day of December 2024

BETWEEN

Rabindranath Tagore University, HOJAI, ASSAM, INDIA is a State Govt. University located at Hojai, Hojai district, Assam. The university is established through the Rabindranath Tagore University Act, XXXIV of 2017 which was passed by the State Legislature of Assam in 2017 and approved by the UGC. 


DISTRICT INSTITUTE OF EDUCATIONAL TRAINING (DIET), KAMRUP, MIRZA ASSAM (A GOVT OF ASSAM INSTITUTE FOR EDUCATIONAL TRAINING UNDER SCERT)

WHEREAS Rabindranath Tagore University (RTU) and DIET KAMRUP are willing to cooperate in the promotion of teaching, research, and innovation, desire to enter into a Memorandum of Understanding for the purpose of fulfilling their objectives in a better way.

I. SCOPE OF COOPERATION

1. Academic programs: Developing new courses, joint programs, and degree-granting programs
2. Research: Joint research projects, exchanging research data, and promoting joint research in areas of interest
3. Faculty and student exchange: Promoting the exchange of academic staff and students, and facilitating mobility between institutions
4. Resource sharing: Sharing library facilities, educational materials, and resources
5. Events: Organizing joint conferences, seminars, workshops, and lectures
6. Professional development: Providing opportunities for faculty professional development
7. Training: Providing training for doctoral students' research preparation and development
8. Intellectual property: Protecting each other's intellectual property rights in accordance with domestic laws.




II. POINTS OF COLLABORATION

1. Both parties agree to cooperate in a spirit of mutual understanding and goodwill to develop intellectual, cultural ties and to strengthen academic collaborations between the two institutions with respect to all disciplines in both the institutions in general.
2. Both parties will make an effort to promote and develop cooperation in the following areas of academic collaboration:
 - a) Joint Online/Offline Teaching Programs
 - b) Joint Research and Capacity Building Programs
 - c) Exchange of Faculty, Research Fellows and Students
 - d) Organize Joint National and International Conferences, Workshops, Conclaves, Symposiums and Publications
 - e) Organize Exhibitions on Sri Aurobindo's vision on Indian Culture and its interpretation.
 - f) DIET in collaboration with Rabindranath Tagore University to develop courses offered by the University for Certificate, Diploma, PG Diploma UG, PG and PhD programmes for the students of Rabindranath Tagore University.
3. This Memorandum of Understanding mandates that both parties shall support the joint activities. In general, each side shall bear the cost for its participation in projects and activities unless otherwise agreed upon.
4. Whilst the purpose of this MOU is to outline an academic and management framework between the Institutions, they do not intend to be legally bound to each other, and this MOU does not impose any legal obligation on either party.

III. INTELLECTUAL PROPERTY RIGHT:

Unless otherwise agreed to, all rights and title to Intellectual Property, whether or not patentable, conceived and reduced to practice, in the performance of the activities under this MOU, exclusively by an employee of any two universities/organizations shall be owned by that university/organization. All rights

and title to Intellectual Property whether or not patentable, conceived and reduced to practice jointly by employees of both universities/organizations shall be jointly owned. Neither University shall use or license to any third party such jointly owned intellectual property for any purpose, whatsoever, without prior written consent of the other university/organization.

IV. COORDINATION COMMITTEE:

There will be a Co-ordination Committee for effective execution of the activities to be carried out under this MOU and for reviewing their progress. The composition of this Committee will be as follows: An official of Rabin Dranath Tagore University nominated by the Vice-chancellor and an official nominated by the 'DIET - KAMRUP' will be the respective coordinators of the committee.

V. CONFIDENTIALITY:


The parties agree that the ownership of and any other rights relating to intellectual property arising from or in connection with any program or activity under this Memorandum of Understanding shall be determined on a case by case basis, and shall therefore be specified and agreed for each such program or activity in a separate written agreement between the parties.

VI. EFFECTIVE DATE AND DURATION OF THE MOU:

This MOU shall be effective from the date it is signed by the parties hereto. The duration of the MOU will be initially for a period of 03 (three) years from the effective date, unless or otherwise terminated earlier, as per Clause 6.

VII. AMENDMENT TO MOU:

No amendment to this MOU shall be valid unless the same is made in writing jointly by the parties hereto or their authorized representatives and specifically stating the same to be an amendment to this MOU.

VIII. TERMINATION OF MOU:

The MOU can be terminated by either party giving the other party, a prior written notice of not less than ninety days of its intention to do so, but without dishonouring any commitment entered into prior to the date of termination notice. This MOU shall also stand terminated for any reason such as legal processes, Acts of the State or similar such exigencies beyond the normal control of the party concerned and which disabled any of the parties hereto from functioning further. Despite termination, the parties shall abide by the usual professional ethics and normal code of conduct to maintain the confidentiality of the information and intellectual property rights.


In case of termination of MoU, both parties should ensure that students enrolled for the joint programs do not suffer. Their course should be duly completed and certificates/degrees should be issued.

IX. DISPUTE RESOLUTION:

Any dispute arising under the terms and conditions of this MOU shall be referred to a competent independent Arbitrator as agreed to by both Institutions

X. FORCE MAJEURE:

For the purpose of this MOU the expression Force Majeure shall mean any clause affecting the performance of a party of its obligations arising from the acts, events, omissions, happenings, or non-happenings, beyond its reasonable control including (but without limiting the generality thereof) government regulations, fire, flood, earthquakes, strikes, or any other disaster or an industrial dispute, affecting a third party for which a substitute third party is not reasonably available. Any act, event, omission, happening, or non-happening will be considered Force Majeure, if it is not attributed to wilful act, neglect or failure to take reasonable precautions of the affected party. Neither party shall whatsoever, including but not limited to any damage or abetment of charges whatever directly or indirectly caused to or incurred by the other party by reason of any failure or delaying the

performance of its obligation hereunder which is due Force Majeure. Notwithstanding the foregoing, each party shall use all reasonable endeavours to continue to perform or resume the performance of such obligations here under for the duration of such Force Majeure event.


