NOTICE

In order to ensure effective monitoring of research activities and compliance with the University regulations governing the Ph.D. Programme, it is hereby notified that the following guidelines shall be applicable to all Ph.D. scholars of Rabindranath Thakur Vishwavidyalaya with immediate effect:

1. **Regular Ph.D. Scholars** shall report to the University regularly and remain engaged in their research work under the guidance of their respective supervisors.
2. In case a **Regular Ph.D. Scholar** is required to remain outside the University for the purpose of field work, laboratory work in another institution, archival research, or any other approved academic activity, the **concerned Research Supervisor** shall submit a written report to the **Academic Registrar** specifying:
 - the purpose of such absence,
 - the place of work, and
 - the period of absence of the scholar.
3. **Part-time Ph.D. Scholars** shall remain physically present in the University for a **minimum of thirty (30) days in each semester** for academic interaction, consultation with the supervisor, research-related activities, and other requirements as prescribed under the University/UGC Regulations.

All Research Supervisors, Heads of the Departments, and Ph.D. Scholars are requested to ensure strict compliance with the above instructions. Any deviation from these guidelines shall be viewed seriously and may attract appropriate action as per the University rules and the applicable UGC Regulations.

This notification shall come into force with immediate effect.
