- 3. Candidate has to send a bank draft, of Rs. 2000 (Non-refundable) in favour of Rabindranath Tagore University, payable at State Bank of India, Hojai Branch, Hojai. The bank draft should be drawn only on or after the date of publication of the advertisement and on or before the last date of submission of application. Application fee sent in other forms will not be accepted.
